- Act No. 47 of 1987 - MUNICIPALITIES FINANCIAL RECOVERY ACT Enacted (Jul 10 1987)
- Act 73 Signed into Law, Amending PMAA (Jun 27 2012)
- CWA board expanded from 5 members to 9 members, and new board terms go into effect (Nov 26 2012)
- Scranton City Council confirms it is looking into sale of Sewer Authority (Feb 14 2013)
- Missouri Passes HB142 regarding acquisition of utilities (Jul 03 2013)
- PA Governor signs into law changes proposed to Act 47. The new law is Act 199. (Oct 31 2014)
- New Jersey Water Infrastructure Protection Act Takes Effect (Feb 06 2015)
- Fairview Township Sewer System Sale to PAWC Announced (May 01 2015)
- First draft of Fair Value Act introduced into the House as House Bill 1326 (Jun 11 2015)
- American Water is one of four bidders for Scranton Sewer System (Jul 28 2015)
- A group of doctors urges Flint to stop using the Flint River for water after finding high levels of lead in the blood of children. State regulators insist the water is safe. (Sep 24 2015)
- PUC approves Fairview Township Sewer System Sale to PAWC (Dec 01 2015)

NMF appeals "deemed denial" of records to the Office of Open Records. (RTKL 2017-137) (Sep 27 2017)

PUC Approves Municipal Authority of the City of McKeesport Sale to PAWC (Oct 01 2017)

PUC Approves Limerick Township Sewer System Sale to Aqua Pennsylvania (Oct 01 2017)

DCED issues a "final determination" along with certain requested documents in redacted form. (Oct 19 2017)

Office of Open Records issues ruling granting appeal and directing DCED to produce responsive documents to the request. (RTKL 2017-137) (Oct 20 2017)

Pittsburg Water and Sewer Authority Placed Under PUC Jurisdiction (Nov 01 2017)

DCED informs NMF that they have located 3 emails between Act 47 coordinator and Aqua America in response to requests 1-11. (RTKL 2017-137) (Nov 03 2017)

Chester Water Authority holds board meeting (Nov 03 2017)

DCED produces revised redactions for the Act 47 status reports. DCED also produces email chain between Act 47 coordinator and Aqua. (RTKL 2017-137) (Nov 16 2017)

DCED appeals OOR decision to Commonwealth Court. (RTKL 2017-137) (Nov 20 2017)
