PRELIMINARY DECREE

AND NOW, this 1st day of April, 2019, upon consideration of the Petition for Approval of Declaration of Trust under Pennsylvania Law and the Transfer of Legal Title to Certain Assets to Said Trust of the Chester Water Authority, it is hereby **ORDERED** and **DECREED** as follows:

b. By mailing postcard notice (“Ratepayer Notice”) to the Authority’s ratepayers via first-class United States mail, postage prepaid, at the address reflected on the records of the Authority and substantially in the form attached to the Petition as Exhibit “B”, which includes a recital that a copy of the Petition, Preliminary Decree and Proposed Decree will be posted and made available on the Authority’s website at <http://www.chesterwater.com> and will be provided in hard copy to any ratepayer who requests a copy, as described in the Ratepayer Notice.

c. By publication of the Notice substantially in the form attached to the Petition as Exhibit “C”, in the Delaware County Legal Journal and the Delaware County Daily Times over a period of two (2) successive dates, starting on April 10, 2019 and ending on April 17, 2019.

2. Counsel for the Authority shall provide Proof of Service to the Authority’s ratepayers by affidavit stating that Notice was mailed to all rate payers in the form attached to the Petition as Exhibit “B” by first class mail, postage prepaid.

3. Hearing on the Petition is scheduled for Wednesday, April 24, 2019 at 9:00 a.m. in Courtroom 10.

4. The Authority shall post this Preliminary Decree on its website at <http://www.chesterwater.com>, within three (3) days of its receipt of this Court’s entry of the Order.
